**SNOW REMOVAL.** Snow removal crews are being challenged beyond usual to clear the roads following the Mono wind event and heavy snowfall of last week. Silvertip and Black Pine are both YACSD private roads. Please remember that snow removal from driveways on these roads may not be blown or pushed onto Silvertip or Black Pine. On street parking is not permitted during snow removal operations, including the cul-desacs, as cars parked there makes turning the plows around even more difficult than usual. If your property is on Railroad or Forest YACSD suggests checking with the county's regulations about removing snow from driveways onto those roads.

**PERMISSIVE BURN DAYS.** Cal Fire has removed burn restrictions for residential burning in regard to having a permit. You are still required to call 888.440.2876 to confirm if that day is a Permissive Burn Day. PLEASE be safe and cautious, especially if there is any sort of a breeze.

SPECIAL MEETING OF NOVEMBER 2, 2020. The Board met via ZOOM to discuss and ultimately approve the receipt and wording of an email from Paul Giuntini regarding access to the YACSD Well #2 West for repairs. He had requested documents and raised questions about permits, which were submitted to him. Mr. Giuntini did give permission for YACSD to access the Silvertip property to complete the repairs on Well #2 West. This was a single subject meeting to expedite the repair. No other topic was discussed.

**WELCOME JOHN HASTRUP** – John has recently been elected to the YACSD board of directors by way of filing for election with Mariposa County. He was sworn in during the December 12 meeting. Welcome aboard John!

**ELECTION OF BOARD OFFICERS.** The officers for the YACSD board were chosen at the December 12, 2020 meeting. BOARD MEETING OF DECEMBER 12, 2020. YACSD board met via Zoo and the call to order was delayed due to technical difficulties. The Audits for FY 2017-18 and 2018-19 have been completed and are posted on the website. Water Master Tim McGinty reports that repairs will be forthcoming on Well #2 West. The ground has been too wet to get equipment out in the meadow. There are still a couple folks who haven't paid their YACSD bills that were due in September. Reminders have been sent out to them and YACSD received two payments by December 31. There are still 2 outstanding bills that were due in September 2020.

PARKING ORDINANCE FOR SILVERTIP LANE, FISH CAMP LANE, FOREST DRIVE, LAUREL WAY AND RAILROAD AVENUE. The Mariposa County Board of Supervisors had their first reading on the Ordinance prohibiting parking, stopping and standing on the roads listed above on December 15, 2020. This is in response to the snow invaders and their effect on the community of Fish Camp. Enforcement will be COMPLAINT DRIVEN. This Ordinance in a result of the previous Ordinance prohibiting parking along both sides of Highway 41 from Jackson Road to the Big Creek Crossing.
