HOW TO SUBMIT PUBLIC COMMENTS:

Public comments prior to the meeting may be emailed to Karen Green at greenbeans 5@comcast.net. Please write Public Comment in the subject line. To provide written comment on an item on the agenda or to address the Board during the Public Forum for items not on the agenda, please note the agenda item number that you want to address or whether you intend for the comment to be included in the Public Forum. If you would like your comment to be read aloud at the meeting (not to exceed 3 minutes) prominently write "Read Aloud at Meeting" at the top of the email. Copies of all timely received written comments will be provided to the Board and will be added to the official record. During the meeting, public comments may be made by phone and on-line participants.

During the public hearing written protests against the Water Service Fee will be considered. If you desire to submit a written protest, it must: 1) identify you as the property owner and state that you oppose the proposed Water Service Fee; 2) provide the location of your parcel (by assessor's parcel number or street address); and 3) include the name and signature of the property owner submitting the protest. To be valid, a protest must be submitted in writing to: YACSD Secretary, P.O. Box 31, Fish Camp, CA 93623. Emailed protests to greenbeans 5@comcast.net will be accepted until the end of the public hearing portion of the agenda. The emailed protests need to follow the guidelines above and be in the form of a scanned letter with a signature.
