**METER READING.** Thank you to all who had their access to and the meter box cleaned out. There were several meter boxes that were completely filled with dirt and had debris over it. Meters will be read the last weekend in June 2022, please plan ahead. Big thanks go to the hard working meter reading crew!

**ANNUAL BILLING.** Bills will go first week in July. Please ensure that that your payment is received by YACSD by September 5, 2021. Thank you for your help in this.

**BOARD MEETING of JUNE 26, 2021.** Chair Patti Frey opened the meeting at 10:00 am in the Tenaya Lodge of Fish Camp. It was good to see people in person.

Water Master Tim McGinty reported that repairs have been completed on Well #2 West. He asked for board members to "divide up" the hydrants for maintenance. He is looking at replacing all of the meters to enable electronic reading as part of the Capital Improvement Plan that is still in development. Tim has plans to flush the hydrants this summer.

Board Vacancy. There still exists a vacancy on the board if any resident is interested. Please contact Chair Patti Frey if you would like to serve.

Grand Jury. Patti Frey announced that she had been served a subpoena from the Grand Jury and has met with them already. Former Chair Dick Ryon had also been served with a subpoena. The Grand Jury Report is due to be released publically June 30, 2021. After that date it can be discussed in a public meeting. The YACSD Board of Directors are required to respond to the Grand Jury report within 90 days. The board has set Wed, July 21, 2021 at 7:00 pm for a public **ZOOM** meeting to discuss the response to the Grand Jury.

Non-payment of Bills. There are 2 properties that have not paid in full their obligation that was due September 2020. Discussion was held as how to proceed. YACSD will follow the guidelines as set forth in the By-laws.

Fish Camp Transfer Station. Tim McGinty announced that he is the new attendant at the Transfer Station that is now held at the NEW FIRE HOUSE. You are welcome to bring your garbage to the dumpster after you have set up an account with Mariposa County Public Works. You will be billed monthly for the number of bags you bring in on Saturday mornings from 8:00 – 10:00 am. There is no charge for recyclable materials.
