PUBLIC RECORDS ACT (PRA) REQUESTS. The YACSD board has received several labor intensive requests for information in the past year. Some requests have required over 6" of files to be produced, redacted and provided. Many documents were transmitted electronically, which eased the load, but it has taken time away from family, friends and projects that would benefit Fish Camp.

EMERGENCY CONTACTS. (1) Mariposa County is now signed up with **Everbridge** to handle the emergency alert system with property owners. If you were previously enrolled through the Nixle program you are automatically enrolled in the **Everbridge** (parent company of Nixle) program. Please download the Everbridge app to enroll, if you weren't enrolled previously. (2) You may also go to **www.msoalert.com** (Mariposa Sheriffs Office Alerts) to sign up for emergency notification through the Sheriff's office. IF you change/add phone numbers or want to add contact info, please contact the programs above. (3) You may text Fish Camp's zip code (**93623**) to **888777** to receive mobile alerts. (4) Having a NOAA radio has been suggested, by the National Weather Service, to give timely alerts to residents.

*Everbridge has sent out a warning of a weather advisory for the next couple days in Fish Camp.

SILVERTIP LAWSUIT STATUS. Our attorney is in the final stage of preparing the out of court settlement agreement with Palm Springs Village that will guarantee the District's water rights in the meadow.

VEGETATION REDUCTION. Cal FIRE has lifted the burning ban in our area. A Burn Permit is **required**. Please go to a Cal Fire station to get a permit. You must call **888.440.2876** prior to starting any burn piles. Please be very careful this year when burning vegetation.
